## Administrators:

Administrator recruitment initiated in the fall of 2021 was concluded in December 2021 and candidates appointed into pools. Candidates from these pools were appointed into administrator assignments for February 1 2022 and upcoming for July 1 2022

Due to increased turnover in administration positions (specifically retirements and leaves absence) the district has initiated a Spring 2022 round of administrator recruitment, which is currently underway.

Once completed, a second announcement of administrator appointments will be issued in late June.

## Management Staff

Generally, management staffing is stable and turnover in management positions remains low and within expected parameters.
